Types of gift

We are very happy to discuss (in confidence) the type of gift that you may want to leave but are unable to offer any specific financial advice. You might want to consider leaving a:

Residuary gift - which is a proportion of your estate, once family and friends have been provided for in your Will.

Pecuniary or cash gift - a specified amount of money you want to leave.

Specific gift - such as a musical instrument* or piece of art.

In general terms the value of any charitable donations will be taken off the value of your estate before inheritance tax is applied; if you leave 10% or more of your net estate to a charity such as Benslow Music Trust then the rate of inheritance tax is reduced. As everyone's estate is different and the tax rules change from time to time, you should discuss this with your tax advisor or solicitor.

*If you would like to donate a musical instrument, you might want to consider bequeathing it specifically to the Benslow Music Instrument Loan Scheme.

How to leave a gift

We recommend that you consult with a solicitor before creating or amending a Will. If you already have a Will in place, you can complete a codicil and place it with your Will. You can also choose to create a letter of wishes. While not legally binding, this document can help your family and friends to understand your desires.
